#### MINUTES OF THE BOARD OF SELECTMEN

Monday, January 26, 2015 – 5:30 p.m. – Town Hall Conference Room

Members Present: Chair John Penacho, John McDevitt, Vaughan Morgan

*Members Absent*: Kevin Forrest, Mo Sodini *Staff*: Karen Anderson – Town Administrator

Chair Penacho opened the Board of Selectmen meeting at 5:30 p.m. A roll call was taken by the Chair; he announced a quorum was present and the meeting was being recorded. NOTE: The meeting was moved to an earlier time due to the anticipated blizzard conditions later in the evening.

### I. ADMINISTRATIVE AND OTHER ITEMS

1. Approval of Minutes: Monday, January 12, 2015

**MOTION:** V. Morgan moved to approve the minutes of Monday, January 12, 2015. Second – J. McDevitt; all in favor. MOTION CARRIED

#### 2. Grapevine Request for Warrant Article Insert: \$1,200

The Town Administrator explained that the Grapevine would need advance notice if the Board agreed to the insert. They would like to do a four page pull-out insert of Town warrant articles in the center of the next edition, which will be published just before voting day. Cost to the Town would be \$1,200. V. Morgan stated that there is ample notice to the public and wasn't sure \$1,200 was justified; the amount was not budgeted. The Town Administrator added that the warrant articles are posted on the website and included in the Town Report. Copies are also available in the Town Hall as well as at Town Meeting. She suggested that additional copies of the warrant articles could be available at the Library, Suds-N-Soda, and other locations. J. McDevitt felt the Grapevine could be beneficial to the elderly who may not be able to get out or were not tech savvy. However, he also couldn't agree with it if it was not budgeted. Chair Penacho suggested it be done as a separate page and posted on the website. J. McDevitt requested the Board be given more notice next year so it could be budgeted.

#### 3. Veteran's Credit

The Veteran's Credit is for a new resident on Maya Way.

**MOTION:** J. McDevitt moved to approve the Veteran's Credit for the resident at 8 Maya Way (Map R3, 9E). Second – V. Morgan; all in favor. MOTION CARRIED

#### 4. COAST Board Representation

The Town Administrator asked the Selectmen for permission to resign from the COAST Board. She has spoken to Mark Fleming, resident and advocate of public transportation, about replacing her; he is willing to serve as the Town's representative on the COAST Board. As a neutral party, he can speak on behalf of public transportation on a more regional basis. In her role as employee, the Town Administrator was restricted by the Board's direction which differed from her personal feelings about public transportation. M. Fleming would be able to address public transportation without any impact on costs and budgets. The Town Administrator stated that board representation for Greenland and Stratham will probably be deleted if the towns are no longer on a COAST route. Stratham voted to zero out their COAST funding.

**MOTION:** V. Morgan moved to authorize the resignation of the Town Administrator from the COAST Board.

DISCUSSION: When asked, the Town Administrator responded that the Board of Selectmen did not have to appoint a replacement. Selectmen would like to meet M. Fleming before formally appointing him as their representative to COAST.

**MOTION:** V. Morgan moved to authorize the resignation of the Town Administrator from the COAST Transportation Board. Second – J. McDevitt; all in favor. MOTION CARRIED

Chair Penacho stated that if COAST wanted a representative from Greenland, they would meet with M. Fleming.

#### 5. Sea Level Committee Update

Peter Kinner, the Town's representative on the Sea Level Committee, will be making a presentation to the Conservation Commission at their meeting on Wednesday, February 11, 2015, regarding sea level rise. The Board of Selectmen will attend if they are available.

### 6. Maya Way Road Bond

Jim Kerivan, Altus Engineering, has reported that Maya Way is complete, and the road bond can be released and accepted; a copy of his letter is on file. The remaining balance of the road bond is approximately \$32,800 plus any accrued interest.

**MOTION:** V. Morgan moved to accept Maya Way and release the remaining bond held by the Town. Second – J. McDevitt; all in favor. MOTION CARRIED
