MINUTES OF THE CONSERVATION COMMISSION

Wednesday, June 15, 2016 – 7:00 p.m. – Town Hall Conference Room

Members Present: Chair Chip Hussey, Laura Byergo, Joe Fredericks *Members Absent:* Bill Bilodeau

Chair Hussey opened the Conservation Commission meeting at 7:00 p.m. A roll call was taken by the Chair; he announced a quorum was present and the meeting was being recorded.

1. <u>Madeleine Dilonno – Summer Intern, UNH Cooperative Extension: Training Needs Assessment</u> <u>Survey</u>

Madeleine Dilonno is a senior at UNH in the Community Environmental Planning program; this summer she is an intern in the UNH Cooperative Extension. She was doing a pre-survey with members and will email them a more in-depth survey. The survey involved the type of training and resources that might be needed to run their meetings more efficiently and effectively. The UNH Cooperative Extension will use the data to update their NH Citizen Planner website. M. Dilonno is hoping to have a full report available at the end of summer.

MOTION: J. Fredericks moved to withdraw \$1,500 from the 2016 Conservation Warrant Article to pay for surveying if funds were not encumbered in 2015; it will require approval by the Board of Selectmen. Second – Chair Hussey; all in favor.
