Vice Chair Winsor opened the Planning Board meeting at 7:00 p.m. A roll call was taken by the Vice Chair; he announced a quorum was present and the meeting was being recorded.

I. PUBLIC HEARING

1. Projects of Regional Impact

There were no projects of regional impact to discuss.

2. Zoning Amendments

After review by the Board and no public comments, all amendments were forwarded to ballot without any further revisions (copy on file).

MOTION: C. Hussey moved to forward Item 1 (Article III, Establishment of Districts and Uses, Table of Uses Subsection A, Residential Uses: amend Item 3 to require a Conditional Use Permit; and amend Article 3.7.12 - Duplexes, by adding Subsection 3.7.12.3, Duplex Conditional Use Permit Criteria) to ballot. Second – S. Gerrato; all in favor. MOTION CARRIED

MOTION: C. Hussey moved to forward Item 2 (Article III, Establishment of Districts and Uses, amend Subsection 3.7.1 (C) to include "retail uses shall not qualify as a cottage industry") to ballot. Second – S. Baker; all in favor. MOTION CARRIED

MOTION: C. Hussey moved to forward Item 3 (Article IV, Dimensional Requirements, Section 4.3, Explanatory Notes, amend by adding new Item 8 for duplex homes in the Residential and Commercial A zones) to ballot. Second – S. Baker; all in favor. MOTION CARRIED

MOTION: C. Hussey moved to forward Item 4 (XVIII, Wetlands Protection Ordinance, Subsection 18.6.1, Conditional Use Permit, amend by adding new Item G to allow wells and associated appurtenance in the buffer/setback areas only) to ballot. Second – S. Gerrato; all in favor. MOTION CARRIED
