MINUTES OF THE CEMETERY TRUSTEES

Tuesday, May 23, 2017 – 7:00 p.m. – Town Hall Conference Room

Members Present: Bob Ellwood, David Gill, Michele Kaulback

Also Present: Paul Hayden - Sexton

Chair Gill opened the Cemetery Trustees meeting at 7:06 p.m. A roll call was taken by the Chair; he announced a quorum was present and the meeting was being recorded.

1. Review of Calendar: Dates to Repair Stones and Remove Stumps

Chair Gill explained that before the road could be repaired, stumps needed to be removed. Stones are being repaired in Hillside Cemetery (lower cemetery). Cleaning will be done after stones are repaired. Stumps will be removed up to the gate to the school, which will take three or four weekends. Schedule follows and is subject to change.

Chair Gill stated that the stone repairs at Hillside Cemetery are a long term project; 90% of the stones need to have work done. Most are a challenge and this will not be a one year project. In addition to Prospect Hill and Hillside, Town cemeteries are located on Breakfast Hill Road, Bayridge Drive, and Bayside Road.

There was no discussion regarding By-Laws. M. Kaulback noted that “NO DUMPING” signs were needed.
