PERMIT FEE SCHEDULE - Effective August 02, 2021

Adopted and Approved by the Board of Selectmen at a Duly Posted Public Hearing: July 19, 2021 Per Title III, Chapter 41, Section 41:9-a

RESIDENTIAL

*The application and permit *do not* include any other permits (electrical, plumbing, mechanical, etc.).*

Permit Processing Fee (Does Not Include Permit Fee*): The processing fee is due at the time of application and is non-refundable, even if the application is denied. It **does not include** the permit fee (see below).

*<u>Minor Residential Permit</u>: Fees are based on the total cost of the project; *each permit must be priced separately*.

| Minor Residential Projects | \$7 per \$1,000 (minimum \$50) |
|----------------------------|--------------------------------|
| Certificate of Completion | \$75 |

*<u>Major Residential Permit</u>: New home construction and projects of \$50,000 or more: one (1) and two (2) family dwellings. The fee is based on the exterior square foot dimensions per floor, including attached garages.

| Major Residential Building Construction | \$0.65 per square foot, per floor |

<u>Required Permits</u>: Minor Residential Permit fee applies; this includes, but is not limited to, all construction projects such as:

- Pools (Above and In-Ground)
- Fences
- Generators: Stand Alone and Portable
- Electrical
- Plumbing
- Mechanical
- Septic
- Alterations, Renovations, Remodel
- Sheds
- Decks
- Gas Installs
- Roofing
- Windows
- Siding
- Retaining Walls
- Fire Pits

COMMERCIAL

*The application and permit *do not* include any other permits (electrical, plumbing, mechanical, etc.).*

Permit Processing Fee (Does Not Include Permit Fee*): The processing fee is due at the time of application and is non-refundable, even if the application is denied.

Minor.....\$100; Check with Building Department

*<u>Major Commercial Permit</u>: New commercial building construction and projects of \$50,000 or more. The fee is based on the exterior square foot dimensions per floor. The application and permit <u>do not</u> include any other permits (electrical, plumbing, mechanical, etc.).

Major Commercial Building Construction...... \$0.80 per square foot, per floor or \$10 per \$1,000

<u>Required Permits</u>: This includes, but is not limited to, all construction projects such as:

- Re-fits and Up-Fits
- Renovations
- Change of Use (also requires Occupancy Permit)
- Addition of Sprinkler or Fire Alarm Systems
- Generators: Stand Alone and Portable
- Electrical
- Plumbing
- Mechanical
- Septic
- Alterations, Renovations, Remodel
- Out Buildings
- Decks
- Roofing
- Windows
- Siding
- Retaining Walls
- Gas Installs

MISC. FEES

Work without PermitDouble the Permit Fee

Re-Inspection Fee......\$100 per inspection (Required when an inspection fails, is not ready at time of inspection, or responsible party is not on site for the inspection. Fee must be paid when a re-inspection is scheduled.)

RSA 676:17

Requires adherence to local ordinances, codes or regulations and adherence to specifications of any plot or plan approved by local land use boards and decisions of local administrators.
